The OHSOTO'KINO Recording Bursary program will provide two opportunities per year for Indigenous artists to create a commercial recording (LP or EP) at Studio Bell. NMC will provide access to Studio Bell's world-class recording studios and "living collection" of musical instruments, which spans 450 years of technical innovation. Indigenous artists will have the opportunity to 'use history to make history.'

Two submissions — one for contemporary music, one for traditional music — will be selected by NMC's National Indigenous Programming Advisory Committee and awarded a one-week recording session at Studio Bell to produce a commercial release.

Artists are provided with:

- One week (5 to 7 days at 8 hours per day) in NMC's recording studios at Studio Bell.
 This will also include:
- An in-house recording engineer.
- An opportunity to use, sample, and record unique instruments from NMC's Collection.
- Accommodation at a hotel within walking distance for the duration of the bursary.
- · Travel stipends for transportation and meals.
- Artist will maintain full rights & control of recording worked on or completed while in the program.

Tekweywinen tel weljesultiek is a multidisciplinary exhibition that will be interactive and play-based. Showcasing seven Indigenous artists based in Wabanaki, this exhibition is a space to lift one another up and embrace Indigenous joy collectively. It will examine L'nu concepts of happiness and its impact on Indigenous and non-Indigenous communities, allowing us space to play and contemplate.

Through this submission process, we invite artists to present their own interpretations of joy. This can be personal and represent your own happiness, or it can be about bringing others joy. Existing works can be submitted for consideration. Newly created works will need to be completed and available in time for the exhibition at The Rooms, on display from Sept 21, 2024, to April 6, 2025. The Rooms may provide some financial supports to assist in the creation of some works, negotiable based on a production budget proposed by the artist.








Intro to Relief with Christine Koch
